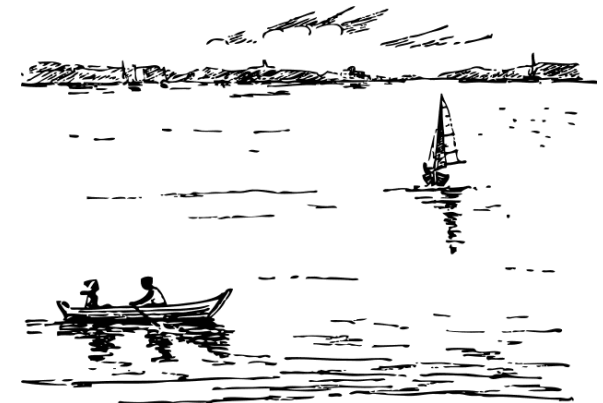

## Landings and Ramps





**A permit is required for launching any vessel, via boat trailer, at all county boat ramp and public landings, effective April 1, 2009.**

*You may launch a kayak or canoe from your car or truck with no fee.*

Maryland Resident	One Day	\$5.00
Maryland Resident	Annually	\$20.00
Out of State	One Day	\$10.00
Out of State	Annually	\$50.00
Permit Violation	First Offense	\$50.00
Permit Violation	Second Offense	\$100.00

**Fees collected will be used for the maintenance of these boating facilities.**

## Regulations

### Caroline County Code Chapter 148

**Annual Permits are valid only when displayed on the drivers side of the vehicle or trailer tongue within 12" of the hitch.**

Daily permits must be hung on inside mirror facing windshield.

## Rules

- Landings are open from dawn to dusk.
- Park in designated spaces only.
- No overnight parking.
- Do not block ramps, parked vehicles, public roads or private driveways.
- No camping or open fires.
- Obey county officials and regulation signs where posted.
- Do not leave boats, trailers, equipment or supplies at any landing, pier, or marina.
- All trash must be taken with you or placed in a trash receptacle.
